**NOTICE IS HEREBY** given that the Gilliam County Court will conduct a Public Hearing at 10:05 a.m. on Wednesday July 22, 2020 at Condon Veterans Memorial Hall, 120 S. Main Street Condon, Oregon 97823.

The purpose of the public hearing is to consider Modification of Conditions of Approval for a Conditional Use Permit issued to Waste Management Disposal Services (WMDS) for a solid waste landfill known as Columbia Ridge Landfill & Recycle Center in the exclusive farm use zone. The property subject to the conditional use permit is described as T2N, 21E, Tax Lots 1101 and 1103. The applicable criteria are found in the Gilliam County Zoning and Land Development Ordinance in Article 7, Section 7.010(A)(4) (Procedures for reviewing/altering Conditional Use Permits) and Section 7.020(K)(R) (Standards governing conditional uses) and Article 11, Section 11.160(B) (Modification of Conditions of Approval).

Interested persons may participate by providing written comment either before or at the public hearing or by providing oral testimony at the public hearing.
