NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY given that the Gilliam County Court will conduct a Public Hearing at 10:15 a.m. on Wednesday November 6, 2019 at the Gilliam County Courthouse, Circuit Courtroom, Rm 207; 221 South Oregon Street Condon, Oregon 97823.

The purpose of the public hearing is to consider the addition of the term of Community Gathering Place to the Definitions section, Section 1.030, of the Zoning Ordinance, then allowing Community Gathering Place as a conditional use in the Limited Industrial Zoned areas in unincorporated portions of the county. This would require additional amendments to the Gilliam County Zoning and Land Development Ordinance (GCZO) and include: Article 4, Use Zones, Section 4.050 Limited Industrial Zone adding as a conditional use Community Gathering Place and Article 7, Conditional Uses, Section 7.020 X, imposing conditions for Community Gathering Place.

Interested persons may provide comment. Written comments or oral testimony may be provided at the public hearing or to staff at the public hearing. If submitting written comments in advance please ensure they are received by 12:00 noon on October 30, 2019. Comments can be submitted via Email to: planning.dept@co.gilliam.or.us or Mail: Gilliam County Planning Director, PO Box 427, Condon, OR 97823 (must be received prior to November 6, 2019 in order to be entered into the record at the public hearing.)
