ORDINANCE

The **COUNTY COURT OF GILLIAM COUNTY, OREGON**, hereby **ORDAINS** as follows:

Section 1: Authority. ORS Chapter 190 authorizes units of local government, including counties, to enter into governmental agreements and to terminate the same.

Section 2: Effective Date. The effective date of the Intergovernmental Agreement shall be the date of its execution between Gilliam County, Sherman County, and Wheeler County.

Section 3: Purpose. The purpose of this Ordinance is to authorize the transfer of all assets and liabilities, including all contracts and agreements with other entities, to **FRONTIER TELENET**, a Chapter 190 entity formed and operated by Gilliam, Sherman, and Wheeler Counties. **FRONTIER DIGITAL NETWORK (FDN)** will be terminated as it is no longer needed as a separate entity and both costs, savings, and efficiency will be promoted by using only one Chapter 190 entity to perform the mission previously done by both entities.

Section 4. Emergency Clause. This Ordinance being necessary for the immediate preservation of the public health, safety, and welfare, an emergency is declared to exist and this Ordinance shall take effect immediately upon its passage,
