GILLIAM COUNTY COURT NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY given that the Gilliam County Court will conduct a Public Hearing at 10:30 a.m. on Wednesday May 3, 2017 in the Circuit Courtroom, Room 207 on the second floor of the Gilliam County Courthouse, 221 South Oregon St. Condon, OR. 97823.

The purpose of the public hearing is to consider marijuana business regulations in unincorporated portions of the county. The purpose of Marijuana Business regulations is to regulate the time, place and manner of marijuana businesses. Additional amendments to the Gilliam County Zoning and Land Development Ordinance (GCZO) are necessary and include: Article 8-Supplemental Provisions adding Section 8.270 Marijuana Businesses allowing and/or prohibiting growing, processing and retailing of marijuana in certain zones and consider amendments to GCZO Article 1, introductory provisions and definitions, to provide clarity; Article 4, use zones, adding reference for marijuana in the land use zones of the county and Article 7, imposing conditions for marijuana businesses.

Interested persons may provide comment. Written comments or oral testimony may be provided at the public hearing or to staff in advance of the public hearing. If submitting written comments in advance please ensure the comments are received by 9:00 a.m. on May 3, 2017. Attn: Planning Director, PO Box 427, Condon, OR 97823 (if mailing comments the comments must be received prior to May 3, 2017 in order to be entered into the record at the public hearing.)
